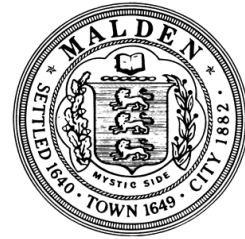

In accordance with Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and Governor' Baker's March 23, 2020 Revised Guidance on Order by the Governor Prohibiting Assemblage of More than Ten People, this hearing will be virtual and conducted via remote participation to the greatest extent possible. No in- person attendance by members of the public will be permitted, and all effort will be made to permit remote public attendance and participation in this virtual hearing via technological means, in the manner specified below, and if available, via public broadcast of the meeting by Malden Access Cable Television on public access television channels.

If you wish to remotely participate in the public comment portion of the hearing:

Using Zoom:

While in the Zoom meeting, click on the "Q&A" button, then click "Ask Question." In the question box that is shown, enter your full name and your home address for the record. This will give the host a timestamped request that you want to speak and we will respond to these requests during the public comment section of the hearing in the order they were received. When it is your turn to speak, a host will announce your name and will unmute your line and allow you to speak.

Dialed In to Phone Conference Only:

*If you are unable to join the Zoom online meeting and are dialed in by phone only and you would like to participate, press *9 on your phone which will indicate a "raised hand" to the meeting administrator. When it is your turn to speak, the meeting administrator will unmute your line and announce the last 4 digits of your phone number to confirm. You must then announce your name and home address for the record.*
